32	<p><u>PLANNING APPLICATIONS AND ISSUES</u> The Parish Council considered the following applications:</p> <p>a) <u>17/0657/CA</u> – land South of Wellhead Lane - fell Norwegian Spruce It was agreed to submit a comment to the Tree Officer, NKDC.</p> <p>b) <u>17/0420/HOUS</u> – 32 Wegberg Road – erection of 2 storey extension There were no comments regarding this application</p> <p>c) <u>17/0634/HOUS</u> – Rose Garden It was agreed to submit comments supporting this application</p> <p>Cllr Kaye added that where the Parish Council supported planning applications from Parishioners it would support a formal response to that effect rather than pursuing the current practice of making no comment on such matters.</p> <p>d) Trees at the School - Nocton Green Following consultation with the Parish Council Insurers, it was agreed that a letter be sent to Nocton School, clarifying the Parish Council’s position and limit of responsibility.</p> <p>e) Fencing at the entrance to the village – B1202 Following notification received from a Parishioner, regarding the erection new fencing, it was agreed that a letter explaining the Parish Council’s views on the matter be sent in reply.</p> <p>f) Nocton Park Road – works Cllr Faulkner reported that Anglian Water had completed their works on the newly re-surfaced road.
