For attractions listed in *red* you may need to apply for a Temporary Events Licence (TENS), or a club licence may need to be extended. Contact North Kesteven District Council Licensing Department for advice on 01529 414155. Stalls selling food will need to comply with Food Hygiene Regulations, further advice is available from North Kesteven District Council Environmental Health Department.

Attractions in *blue* are safety critical. The Parish Council will need sight of all relevant risk assessments, safety certificates for rides and liability insurance. It is unlikely that the Parish Council will give permission for any event that involves fireworks or pyrotechnics, unless they are run by a professional company. Model aircraft flying displays are high risk and unlikely to be approved. Bouncy Castles and similar will not be approved.

Important - Do not book or commit to any financial expenditure until the Parish Council has given outline approval for your event.

Final approvals will not be confirmed until close to the event date by when you will have been expected to have complied with all of the Parish Councils event organisation requirements.
